Roll-Off Dumpster Service Agreement

A. Terms of Service

- The City of Augusta will provide roll-off dumpster containers to customers within the corporate limits of the City of Augusta and rural customers within the established Growth Area.
- Roll-off dumpster containers will be set on private property at the address requested for delivery, *under no circumstances will dumpsters be set in the street or any part of the public right-of-way.*
- Customer warrants that any right-of-way provided by Customer for the City of Augusta's equipment is sufficient to bear the weight of all equipment and vehicles reasonably required to perform the service herein contracted. The City of Augusta shall not be responsible for damage to any private driving surface, pavement or accompanying sub-surface of any route reasonably necessary to perform the service herein contracted and Customer assumes all liabilities for damage to driving surfaces, pavement or road surfaces and entire container placement site.
- Roll-off dumpster service is for a *maximum period of 14 days* and includes delivery, pick-up, and one dump at the appropriate facility, depending of the contents of the container. Rental is subject to the availability of the requested size.
 - Roll-off dumpsters shall be picked up by the City of Augusta after 1:00pm on the 14th day of service or at the customer's request, whichever comes first.
 - Customer agrees to provide clear access to the dumpster.
 - *The roll-off container can only be filled level full*, nothing hanging over or sticking out of the container.
 - If the dumpster is not ready for pick-up when Solid Waste crews arrive, an additional Trip Fee of \$25 per trip may apply.
- Roll-off dumpster deliver/pick-ups must be scheduled one (1) day in advance.
 - Monday – Friday, 8:00am - 4:30pm, no weekend service will be provided.
- The customer and Solid Waste driver shall jointly perform a pre-service inspection of the container upon delivery to the site in order to note any existing damage to City property; pre-service damage shall be documented in the appropriate section of this Service Agreement. The customer and the Solid Waste driver shall jointly perform a post-service inspection of the container before the container is loaded onto the truck; post-service damage shall be documented in the appropriate section of this Service Agreement. Customer may be held liable for any damage incurred to city property during the rental period.
- *Disposal of brick, concrete, rocks, gravel, other masonry materials, and soil shall be restricted to 10-yard and 20-yard roll-off dumpsters only.*
- *Disposal of acceptable yard waste shall be restricted to 10-yard and 20-yard roll-off dumpsters only.*

- Acceptable materials for roll-off services going to the Butler County Landfill include typical and allowable municipal waste of construction/demolition materials. Questions of allowable materials must be directed to the Butler County Landfill at (316) 322-4158.
- The following items are prohibited from being discarded in the roll-off dumpster: tires (whole or processed), paint, appliances containing refrigerant, or household hazardous waste. Any prohibited items discarded in the roll-off container shall be the sole responsibility of the customer. Under no circumstances will the City of Augusta be responsible for the cost of disposal of such items. Customer will be invoiced for the cost of disposal for unapproved items, as determined by the Butler County Landfill. B. Acceptable and Unacceptable Materials

Acceptable Construction and Demolition Materials – Butler County Landfill	
Electrical wiring / components containing no hazardous materials	Plumbing fixtures and pipe
Construction related packaging (except chemical containers)	Wall and/or floor coverings
Mobile homes and trailers (except the tires and fuel tanks)	Wood and wood products
Bricks, concrete, rock, and other masonry materials	Plaster and drywall
Non-asbestos insulation	Roofing materials

Note: Flooring, siding or roofing material containing non-friable asbestos should be handled so it remains non-friable (e.g. carefully removed prior to demolition of structure), transported wet (covered with a mist spray to suppress dust) or transported with tarp cover, and covered immediately at the landfill.

Unacceptable Construction and Demolition Materials – Butler County Landfill	
Drums or chemical containers of any kind (including caulking tubes, oil containers, etc.)	
Oils (motor, transmission, hydraulic, antifreeze, etc.)	Tires (whole or processed)
Spray paint cans, containers, or aerosol cans	Paint cans (full or empty)
Appliances containing refrigerants	Friable asbestos
Household hazardous waste	Yard waste

Note: Household hazardous waste includes but is not limited to automobile fluids and batteries containing toxic components, cleaning agents, herbicides/pesticides, chemical products/cleaning agents, refrigerants, solvents, lead paint chips, paint of any kind, volatile or flammable liquids, fluorescent tubes, and any other waste deemed unacceptable by the Butler County Landfill.

- Materials not accepted at the Construction & Demolition Landfill shall be dumped at the Municipal Solid Waste Landfill, Household Hazardous Waste facility or the Electronic Waste facility at the Butler County Landfill. Contact (316) 322-4158 for more information. Dumping unacceptable materials may result in additional fees to the customer.
- Certain yard waste material may be disposed of in 10-yard or 20-yard roll-off dumpster containers to be disposed of at the City of Augusta. Acceptable material include: tree branches, twigs, and tree trunks. **Due to material separation requirements for yard waste, prior coordination with the City of Augusta is required.** Grass clippings, tree leaves, Poison Ivy, and similar yard waste materials are not acceptable to be disposed in the roll-off container to be dumped at the City of Augusta Compost Site. Disposal of Poison Ivy and other similar yard waste materials shall be coordinated with the Butler County Landfill. Garbage, trash, and bulky items are not acceptable to be disposed in the roll-off dumpster to be dumped at the City of Augusta Compost Site.

C. Service Fees

- Customers who request a roll-off dumpster shall be assessed a rental fee in accordance with the adopted Fee Schedule.

- The rental fee includes delivery, pick-up, and one dump at the appropriate facility, depending on the contents of the containers. The rental fee includes a set tonnage at the Butler County Landfill as described in the table above. If the weight of the dumpster exceeds the tonnage included in the rental fee, the customer will be invoiced the additional weight at a rate of \$33/ton.
- If the roll-off dumpster container is not ready to be picked-up at the time Solid Waste crews arrive, or if the roll-off dumpster container is not accessible, the customer may be charged an additional Trip Fee of \$25/trip. The customer will be invoiced the total amount for additional Trip Fees at a rate of \$25/trip at the conclusion of service. *In order to avoid this fee, it is the customer's responsibility to ensure the container is not over filled, does not contain any unacceptable material, and that the container is accessible to city crews.*
- Post-service invoices issued by the City of Augusta shall be billed in accordance with standard city utility billing procedures. Any unpaid balances remaining after 90-days for utility customers shall be included on the customer's utility account. Any unpaid balances remaining after 90-days for non-utility customers shall be given a reasonable attempt to collect the debt, in accordance with city policies and laws pertaining to debt collection. If the debt remains unpaid after 90-days, the unpaid balance will be referred to a debt collection agency. The customer will be responsible for paying all costs associated with the debt collection and may be ineligible for future roll-off dumpster services through the City of Augusta.
