Minutes: Richardson made a motion to approve the minutes from the March 16, 2020 Council meeting. Reavis seconded the motion. Motion carried without opposition.

Ordinance: Crum made a motion to approve Ordinance 3A dated 3/18/2020. Richardson seconded the motion. Motion carried without opposition.

Reavis made a motion to approve loan/grant agreements with Sugar Shane's LLC for \$76,000, Miller's 5 for \$15,000, Boutique 1631 for \$12,250, The Shop, Inc. for \$35,000, Hunn Leather for \$35,000, Village Decorative for \$35,000 and Patterson Elite Performance for \$150,000 for a total of \$358,250. Huddleston seconded the motion. Motion carried without opposition.
