Temporary Dumpster Service Agreement

A. Terms of Service

- The City of Augusta will provide temporary dumpster containers to customers within the corporate limits of the City of Augusta.
- Temporary dumpster delivery / pick-ups must be scheduled one (1) day in advance
 - Monday – Friday, 8:00am – 4:30pm, and Saturday, 8:00am – 12:00pm
- The dumpster containers will be set on private property at the address requested for deliver. Under no circumstances will dumpster be set in the street or any part of the public right-of-way. Customer also agrees to provide clear access to the dumpster.
- Customer warrants that any right-of-way provided by Customer for the City of Augusta’s equipment is sufficient to bear the weight of all equipment and vehicles reasonably required to perform the service herein contracted. The City of Augusta shall not be responsible for damage to any private driving surface, pavement or accompanying sub-surface of any route reasonably necessary to perform the service herein contracted and Customer assumes all liabilities for damage to driving surfaces, pavement or road surfaces and entire container placement site.

B. Acceptable and Unacceptable Materials

- Acceptable materials for temporary/commercial services includes typical and allowable municipal/household waste. Customers are encouraged to contact the Sanitation Department or more information at (316) 775-4510.
- Unacceptable materials include:
 - **Yard waste:** Grass, weeds, tree limbs, dirt, lawn & garden trimmings, rocks, sand, stumps, leaves, compost
 - These materials may be dumped at the City of Augusta Compost Site
 - **Hazardous Material:** Anti-freeze, oils (motor, transmission, hydraulic, etc.)paint, paint solvents, poison, radioactive or combustible material
 - These materials may be dumped at the Butler County Landfill Hazardous Waste facility
 - **Construction Material:** Bricks, concrete, masonry materials, plumbing fixtures, pipe, roofing materials, wall/floor coverings, plaster/drywall, wood/lumber
 - These materials may be dumped at the Butler County Landfill Construction & Demolition
 - **Furniture:** Any large bulky items or electrical appliances
 - These materials may be dumped at the Butler County Landfill Solid Waste or Electronic Waste facilities
