ORDINANCE NO. 2126

AN ORDINANCE CHANGING THE ZONING CLASSIFICATION OF CERTAIN PROPERTY LOCATED IN MEADOWVIEW ACRES WITHIN THE CITY OF AUGUSTA, BUTLER COUNTY, KANSAS FROM THE PRESENT RESIDENTIAL DISTRICT – DIVISION 1 "R-1" TO THE PUBLIC AND PRIVATE RECREATION DISTRICT – DIVISION 1 "PR-1" AND AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF AUGUSTA, KANSAS.

WHEREAS, notice of a December 18, 2017 Augusta Planning Commission public hearing on Zoning Case Number Z2017-07 changing the zoning classification of the herein described real property located within Butler County, Kansas from the present Residential District – Division 1 to the Public and Private Recreation District – Division 1 was published in the official city newspaper on November 25, 2017 and mailed on November 22, 2017 to all owners of record of lands, within the corporate limits of the City of Augusta, located within 200 feet of the proposed zoning change and outside the corporate limits of the City of Augusta, located within 1,000 feet of the proposed zoning change; and

WHEREAS, the Augusta Planning Commission conducted a public hearing on December 18, 2017 on changing the zoning classification of the herein described real property located within the corporate limits of the City of Augusta, Kansas from the present Residential District – Division 1 to the Public and Private Recreation District – Division 1, and thereafter, based upon the public hearing and a discussion of the factors to consider in re-zoning, voted to recommend approval of said zone change by the governing body; and

WHEREAS, 14 days have elapsed since said public hearings and no protest petition has been filed with the City of Augusta City Clerk.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF AUGUSTA, KANSAS:

Section 1. Zone Change

The official zoning classification of the property hereinafter described is hereby changed from the present zoning classifications of Residential District – Division 1 to the Public and Private Recreation District – Division 1. Said property is legally described as follows:

*Section 15, Township 27, Range 04E, Lots 2-18, Block 1, Meadowview Acres Addition to the City of Augusta, Butler County, Kansas;*

*Section 15, Township 27, Range 04E, Lots 6, 8-16, Block 3, Meadowview Acres Addition to the City of Augusta, Butler County, Kansas;*

*Section 15, Township 27, Range 04E, Lots 1-6, Block 4, Meadowview Acres Addition to the City of Augusta, Butler County, Kansas; and*

*Section 15, Township 27, Range 04E, Lots 4-7, Block 5, Meadowview Acres Addition to the City of Augusta, Butler County, Kansas;*

Section 2. Zoning Ordinance and Map Amendment

City of Augusta Ordinance Number 1788 and the official zoning map of the City of Augusta, Kansas are hereby amended in accordance with Section 1 of this Ordinance.

Section 3. Effective Date

This Ordinance shall take effect and be in force thirty (30) days from and after its publication in the official city newspaper.
